2. That they will be entitled to contributory Pension scheme notified by the H.P. Govt finance Department, vide notification No. Fin.(Pen.)(A)(3)01/96 dated 15.05.2003 and further adopted in HPSEBL.
3. That they will have to produce a medical fitness certificate from the Medical Officer of the HP Govt.
4. That they will be governed by the Group Saving linked Insurance Corporation of India as introduced in HPSEBL.
5. That their regularization is subject to the verification of their character and antecedents.
6. That their service condition will be governed by the HPSEBL Rules/Regulation framed there under from time to time.
7. Their seniority will be determined according to the rules of HPSEBL.
8. That their pay will be determined according to the rules of HPSEBL.
9. That on their regularization, they will not claim the benefit of pay fixation seniority etc of previous service rendered on contract basis.
