2. The Promotion/posting orders of other incumbents who have been recommended by the D.P.C. will be issued separately.

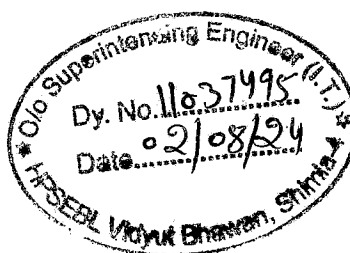
