

In case of refusal of the same by the borrowing Department the individual employee concerned shall contribute the same himself. In case of non-receipt of the same from the Borrowing Department or from the individual employee concerned, he/ they will not be entitled to pension and other retiral benefits for the period of deputation/secondment from the HPSEB Limited.
