In pursuance to order dated 10.07.2024 endorsed vide No.HPSEBL/SECTT/V&I/8-2648/2024:630-41 dated 10.07.2024 and on the recommendations of Class-I DPC, the H.P.State Electricity Board Ltd. is pleased to promote Sh. Yashwant Singh, (DOB:03.03.1982) presently working as Junior Engineer(Electrical) in the office of SE(DSP) under CE(SP), HPSEBL, Shimla as Assistant Engineer (Electrical) against the 40% quota of Diploma holder in the level 18 of the Pay Matrix of ₹59900-189800/- on notional basis w.e.f. 3.6.2023.

All the aforesaid officers in whose case change of station is involved will be entitled to usual TTA/Joining time as admissible under the rules & no extension in joining time will be granted.
