HIMACHAL PRADESH RAJYA CHAYAN AAYOG, TERMS AND
CONDITIONS (CHAIRMAN AND MEMBERS) RULES, 2024

NOTIFICATION

No. Per (AP-B)B(1)-2/2024 Dated Shimla-171002, September, 2024 ^{17/5}


In exercise of the powers conferred by article 162 read with proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh is pleased to make the rules regulating appointment, terms and conditions of the Chairman and Members of the Himachal Pradesh Rajya Chayan Aayog, Hamirpur, namely :-

1. Short title and commencement: (1) These rules may be called the Himachal Pradesh Rajya Chayan Aayog, Terms and Conditions (Chairman and Members) Rules, 2024.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

2. Definition: In these Rules, unless the context otherwise requires: -

- (i) "Aayog" means the Himachal Pradesh Rajya Chayan Aayog (HPRCA), Hamirpur.
- (ii) "Chairman" means "Chairman" of the Aayog, as appointed by the Government of Himachal Pradesh from time to time.
- (iii) "Member" means "Member" of the Aayog, as appointed by the Government of Himachal Pradesh from time to time.



(iv) 'The total monthly emoluments' means "emoluments" as defined by the Government from time to time.

3. Appointment & Term of office of Chairman & Member – (1) The Chairman and Member(s) of the Aayog shall be appointed by the State Government for a period of 02 (two) years only from the date he/she enters upon his/her office, which will be extendable upto one more year, if considered appropriate by the State Government or until he/she attains the age of 65 years, whichever is earlier.

(2) The Chairman shall be appointed from amongst the persons who have rendered atleast 10 (ten) years service under the State or Central Government, as the case may be, and who have drawn the last pay in the pay matrix atleast equal to or higher than the Secretary under the State Government.

(3) One Member shall be appointed from amongst the persons who have rendered atleast 10 (ten) years service under the State or Central Government, as the case may be, and who have drawn the last pay in the pay matrix atleast equal to or higher than the Special Secretary under the State Government.

4. Resignation, Suspension and Removal – (1) The Chairman and Member may by notice in writing under his/her hand addressed to the Governor, HP resign his/her office.

Provided that the Chairman or Member, shall unless he/she is permitted by the Governor to relinquish his/her office sooner, continue to hold office until the expiry of three months from the date of receipt of such notice or until a person duly appointed as his/her successor enter upon his/her office or until the expiry of his/her term of office, whichever is earlier.

(2) The Chairman or Member may be suspended and removed from his/her office by the Governor on the ground of proven misconduct after conducting a due inquiry in which he/she is given reasonable opportunity of being heard.

5. Oaths – (1) The Chairman and Member shall, on appointment, be required to take the oaths of allegiance, office and secrecy in the forms appended to these rules.

(2) The oath will be administered to the Chairman of the Aayog by the Chief Secretary to the Government of Himachal Pradesh and to the Members by the Chairman of the Aayog.

6. Pay and allowances – The Chairman and Members appointed to the Aayog shall receive fixed pay package, as under:-

1. Chairman	₹1.35 lakh per month
2. Member	₹1.20 lakh per month

Note : (1) No allowance/increment of any kind will be admissible on this fixed pay package.

(2) In case of appointment of a person serving on a regular basis in any Central/State Government, PSUs/Board/ Corporation of Central/State Government, Central/ State University or Local Body, as Chairman/Member, his/her appointment will be treated on deputation basis during the period of his services in AIS/ present cadre on such Terms and conditions and pay/allowances as determined by DoP.

7. Leave: Earned leave, Half Pay Leave, Commuted leave, on the basis of medical certificate, Extra Ordinary Leave for Civil Commotions etc. as per the provisions of CCS (leave) Rules, 1972. Casual Leave @ one day for every completed calendar month in respect of the Chairperson and Members shall be sanctioned by the State Government, in the Department of Personnel.



8. Encashment of un-utilized earned leave - The Chairman and Member shall be entitled to the grant of cash payment in lieu of un-utilized earned leave due on ceasing to hold the office as Chairman and Member subject to maximum of 90 (ninety) days.

9. Status / parity - The Chairman and Members of the Aayog shall have parity with the Principal Secretary and Secretary respectively, only in respect of the Medical Attendance, Travelling, Daily & mileage Allowances.

10. Power to relax and to remove difficulties - (1) Where the State Government, in the Department of Personnel, is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to category of persons or posts.


(2) If any difficulty arises in giving effect to the provision of these rules, the State Government (in the Department of Personnel) may make such provisions or give such directions as may appear to it necessary or expedient for removal of such difficulty.
