

OFFICE ORDER

Sub:- Grant of Dearness Allowance to the employees of the HPSEBL.

In continuation to this office order No. HPSEBL/(SECTT)/R&E/14-71/24-25-10121-341 dated 7.06.2024. The Himachal Pradesh State Electricity Board Ltd; is pleased to order that the Dearness Allowance payable to the employees of the HPSEBL shall be enhanced @ 4% from the existing rate of 38% to 42% w.e.f.1st October,2024 on the following terms and conditions:-

1. This Additional rate of Dearness Allowance shall be paid in cash with the salary of October,2024 payable on 28th October, 2024 and the arrears accrued from 01.01.2023 onwards shall be paid in the manner as may be prescribed on this account by separate orders.
2. The Dearness Allowance for all NPS subscribing employees will be regulated by separate orders issued from time to time.
2. These orders will be applicable to regular and work charged employees covered by HP State Electricity Board Ltd; (Revised Pay) Regulation,2016.
3. The payment because of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
4. Other terms and conditions as contained in OM of even number dated 3rd January, 2022 shall continue to be applicable.
