“ORDER”

WHEREAS, **Er. Anamika Sharma (DOB 01.04.1992)**, initially appointed as Assistant Engineer (Electrical) on regular basis vide letter No. HPSEBL (SECTT.) 101-28/14 -43703-07 dated 29.10.2014; she assumed her duties on 07.11.2014 in the office of Superintending Engineer PR&ALDC, HPSEBL, Totu. Thereafter she was promoted as Sr. Executive Engineer on adhoc basis vide office order No.118 dated 25.06.2021 and joined as such as Sr. Executive Engineer, M&T Division, Kangra. Thereafter she proceeded on extra ordinary leave without pay w.e.f. **23.08.2021 to 23.08.2023 (24 months)** for studying two years course (M. Engg.) in Electrical Power Engineering from University College Dublin, Belfield, Dublin, Ireland.


AND WHEREAS, after expiry of extra ordinary leave without pay she was due to resume her duty on 24.08.2023, but she did not assume her duties on due date . Thus this office had requested/ directed her to assume her duty within seven days vide letter dated 20.12.2023, but instead of joining her duty back she requested for extension of EOL vide her letter dated 26.12.2023. Thereafter time and again this office made correspondence with her to join her duty vide letter dated 16.01.2024 & 22.03.2024, but she failed to join her duty.

AND WHEREAS, an explanation of Er. Anamika Sharma was called upon vide letter No. HPSEBL (SECTT.) GE-EOL/23- 86773 dated 30.03.2024 and No. HPSEBL (SECTT.) V&I/8-2932/24 - 613 dated 08.07.2024 to explain the reasons of non compliance of order dated 16.01.2024.

AND WHEREAS, she has submitted her reply on dated **17.08.2024 via mail** that due to personal reasons she tendered her resignation,

NOW THEREFORE, after completion of all codal formalities under Rule 26(CCS) Pension Rules 1972, the H.P. State Electricity Board Limited is pleased to accept the resignation tendered by Er. Anamika Sharma, Sr. Executive Engineer (Electrical) from the services of HPSEBL w.e.f. **23.08.2021 (F.N).**


