But it is regretted to point out that instructions issued by this office and Govt. of HP as well are not being complied with by the field offices as they are still not relieving the incumbents who are under orders of transfer. The violations of non compliance have been viewed seriously by the Board Management.

In view of above, all the field officers are hereby advised to look into the matter personally and ensure that all transfer orders issued by the Board are implemented in toto and that too within the prescribed time limit as stipulated by the Govt. of HP. It may be noted in future that, if any, transfer order is not implemented by the concerned field officer, action deemed fit shall be initiated against the Controlling officer for disobeying the orders as per Conduct Rules.
