



**The bidder shall have to furnish adequate documentary evidence in support of qualifying requirements stipulated as under:**

1. The eligible bidders should have License from CPWD/PWD/Himuda.
2. The bidder should be financially sound and average annual turnover of the bidder for the past 2 years out of last 3 years should be equal/above to the NIT amount i.e. Rs. 3,48,952.73/- only. As proof of turnover the bidder shall have to produce a certificate from the Bank/ Chartered Accountant.
3. The bidder should have experience of such type of work. The work done certificates and work in progress list be separately attached along with the Tender document as well as scanned and signed copies of the same are uploaded along with the tender document.
4. The bidder should have Income Tax/EPF/GST registration as required under rules.
