Pattern)</p> <p>(ii) Pay Band Rs. <b>38100-120400</b> (Level-10) will be allowed as per H.P. Civil services (Revised Pay) Regulation,2022. The Grade Pay to be given to the 50% of the total number of posts of Junior Office Assistant (Accounts) in the cadre after minimum 5 years of regular service as Junior Office Assistant (Accounts) in the cadre and the incumbent(s) of this post shall be designated as Junior Assistant (Accounts) by placement.</p>	<p>“(a) <u>Pay scale for regular incumbent(s):</u></p> <p>Level 4 of the Pay Matrix i.e. (Rs. 20600-65500) (on the pattern of H.P.
