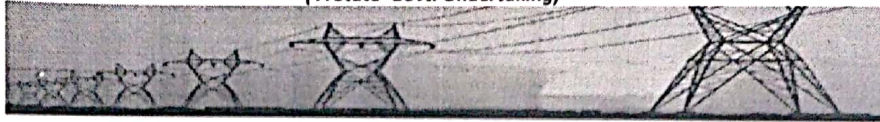

Further, the expenditure on account of the same shall be charged to relevant head of account.

Further, it has been observed that some of the participants do not attend the training programme and hence, the controlling officers of all the above participants are hereby directed personally to ensure the presence of the participants so that the training programme may be fully utilized.
