

Their regularization to the above post(s) is further subject to the following terms and conditions:-

1. Regularization is being considered against vacancy of direct quota posts in HPSEBL.
2. All the Head of Office/DDOs concerned may verify the original certificates of these officials viz. Himachali, Academic, Technical Qualification, SC/ST/OBC/ESM/Disability/IRDP at the time of their joining on regular basis.
3. The Character & Antecedent Report of official **appearing at Sr. No. 12** needs to be verified from the concerned competent authority within the period as required under rules.
4. Seniority will be assigned from the date of regularization in order of their merit obtained in the selection process of respective batch of recruitment.
5. The candidate should be medically fit for the post (except disabled person) and necessary medical fitness certificate duly issued by the CMO concerned may be obtained before releasing pay of regular post.

The contractual appointees who are regularized shall be liable to be posted anywhere in the State.

Necessary entry to this effect is required to be recorded in the service book of concerned officials.


