
Sir,

In this context, it is again intimated that there is 01 post each of Executive Engineer & Assistant Engineer sanctioned in the Directorate and are lying vacant since long and due to non availability of regular incumbents of these posts, the work of this Directorate is suffering badly.

As per the provisions of relevant R & P Rules, the posts of Executive Engineer & Assistant Engineer in the Directorate are filled-up by deputation from amongst the incumbents of HPPWD/I&PH Department as under:-


