

Before issue of the tender documents, the bidder shall have to furnish adequate documentary evidence in support of qualifying requirements stipulated as below.

1. Terms & Conditions: -

i) The contractor/firm documents shall be submitted in online mode: -

- The Bidder should have A-Class license from the Chief Electrical Inspector (HP). The Bidder from Outside HP should also be registered with Chief Electrical Inspector anywhere in the Country but they have to register with Chief Electrical Inspector HP within three Months of the Letter of Award.
- The Bidder should have C-Class license of Civil registration from approved by HP PWD Department.
- The contractor/firm (Company) registered in India would be considered eligible/pre-qualified if he has/they have executed similar nature of works awarded to him/them during the preceding certificate by the work awarding authority is obtained and submitted, fulfilling the criteria as per SBD detailed below: -
 - Three works costing each not less than 60% of the given estimated cost OR
 - Two works costing each not less than 70% of the given estimated cost OR One work costing not less than.
 - 80% of the given estimated cost Bidder should have valid PAN No. & GST registration as required under rules.
- The bidder will declare on non-judicial stamp paper that he is not black listed by any State Govt. agency/deptt. in last five years. Price bid will be opened/submitted only on qualified bidders' eligibility criteria as mentioned.

ii) The Earnest money shall be received in only on online mode. The EMD available against other works will not be transferable to this tender.

- 1) The tender sale, receiving and opening dates including cost of tender document mentioned above.
- 2) Schedule of quantity where contractor will quote his offer for rates/percentage.
- 3) The bidders may ask for any clarification from the office of undersigned on any working day to H.D.M D/B.
- 4) The bidder or his representative should inspect the site and make the conversant with the site conditions.
- 5) In case the scheduled date of opening of tender happens to be a holiday, the tenders shall be opened on the next working day.
- 6) The validity of offer shall be applicable for 30 days from the date of opening of tender.
- 7) The telegraphic tenders or conditional tenders shall not be entertained/accepted.
