OFFICE ORDER

Of late it has been observed that very often Associations/Union/Joint Front of the HPSEB Ltd. Employees are organizing gate meetings, dharnas, protest rallies, demonstrations and strikes etc. in the premises of the Vidyut Bhawan, Kumar House / field offices during office hours. Such protests, rallies, dharnas, gate meetings, demonstrations and or strikes etc. not only creates noise pollution in the complex but also destroys the tranquility and congenial working atmosphere in the premises. At times, it has also been noticed that the employees working in their respective office(s)/branches are dragged and forced to join such gate meetings, dharanas, protest rallies and/or strikes etc. against their "will" and intimidated with dire consequences.


In view of above, it is hereby ordered by the competent authority that no Association / Union / Joint Front etc. shall hold any gate meetings, dharnas, protest rallies, demonstrations and / or strikes etc. within the premises of the Vidyut Bhawan, Kumar House or any official premise of HPSEB anywhere in the state hence forth and any such action of any Association / Union / Joint Front to the contrary, shall be viewed as subversive of the discipline and appropriate action for such unlawful assembly and violation of the orders shall follow.

All the Head offices of HPSEB Ltd. in the state shall ensure that above instructions are followed strictly and violation, if any, be reported to this office.

In case the Head of office conceals the violations, he/she would be liable for action.


The aforesaid orders / directions may be followed meticulously by all and any breach thereof shall be viewed very seriously.
