NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 26.05.2026 (1st Phase), 28.05.2026 (2nd Phase) and 30.05.2026 (3rd Phase) as paid holidays in the State of Himachal Pradesh on account of general elections to Panchayati Raj Institutions on the respective dates. All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh including those covered under Industrial Disputes Act, as well as Shops and Commercial Establishments situated in the concerned area of the Panchayati Raj Institutions shall remain closed on the above said dates. This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

Further, it is clarified that this Election Programme shall not be applicable apply to the Gram Panchayats Karjan & Soyol of Development Block Naggar and Jaban & Namhog of Development Block Anni of District Kullu, H.P.

It is also clarified that special casual leave may be granted to those employees who are working at different places in the State but have a right to vote in above Panchayati Raj Institutions subject to production of certificate from the concerned Presiding Officer confirming that the employee has actually cast his/ her vote.




