Fuel and Power Purchase Adjustment Surcharge (FPPAS) for the month of February, 2026.

Hon'ble HPERC vide notification No. HPERC-F(1)-67/2023 dated 29.11.2023 which has been published in Rajpatra, HP on 07.12.2023 has notified the HPERC(Multi Year Wheeling Tariff and Retail Supply Tariff), Regulations,2023 which provides for levy of Fuel and Power Purchase Adjustment Surcharge (FPPAS).


As per above HPERC Regulations, the FPPAS for the month of February, 2026 has been calculated on the basis of Power Purchase Data received from the office of CE(SO).

In accordance with the authority conferred vide BoD approval through item No. 70.15 of the 70th BoD meeting dated 03.07.2024, FPPAS @ 0.132 Rs./unit is to be levied upon the consumers in the bills of May, 2026 (i.e. energy consumed in April, 2026)
