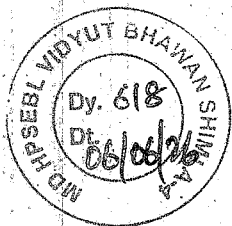
2. For better and full utilization of various air services of Aircraft(s) including helicopter(s) operating within the State under UDAN Scheme of Government of India or operating after entering

The issue regarding seeking approval for undertaking journey(s) by air, especially by the non entitled class of officer(s)/official(s) had been engaging the attention of the Government for quite some time past and after careful consideration, it has now been decided that in partial modification of this Department's letter of even number dated 07.03.2017, the provision of Para-(vi) under SOE "Travel Expenses" shall be substituted as below:-
