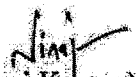
Imposing a complete ban on Transfers- regarding.

Sir/Madam,

I am directed to invite your attention to this Department's letter of even number dated 6th April, 2026, whereby a complete ban on the transfer of all State Government officers/officials was imposed until further orders. In this regard, it is re-iterated that the aforesaid ban shall continue to remain in force and no transfer of any State Government officer/official shall be ordered till further instructions are issued by the Government in this behalf. It is further reiterated that no transfer of any officer/official shall be ordered without obtaining the prior specific approval of the competent authority, strictly in accordance with the provisions contained in Para-8 of the *Comprehensive Guiding Principles-2013* circulated vide OM NO. Per (AP-B) -E (3)-17/2012, dated 10.07.2013 governing the transfer of State Government employees, as amended from time to time.

2. All concerned are requested to ensure strict compliance with these instructions in letter and spirit. These instructions may be disseminated forthwith to all subordinate offices and brought to the notice of all officers/officials under their administrative control. Any deviation from these instructions shall be viewed seriously.
