Sub: Settlement Rate in respect of Roof Top Solar PV Consumers/Prosumers for Financial Year 2025-26.

In the subject cited matter, it is informed that as per Himachal Pradesh Electricity Regulatory Commission (Rooftop solar PV grid interactive system based on net metering) regulations, 2015 & subsequent amendments, the rates for settlement of surplus power exported to the Grid by eligible Roof Top Solar PV Consumers /Prosumers during the FY 2025-26 which remains unadjusted at the end of current settlement period (FY 2025-26) shall be as under:

1. For all eligible categories of consumers to whom the Letter of Approval is issued on or before **15-11-2018**:

For single Part Consumers	Rs. 2.50/kWh
For two Part Consumers	Rs. 2.25/kVAh

2. For all eligible categories of consumers to whom the letter of approval is issued after **15-11-2018** and on or before **31-08-2022**:

For Domestic Category Consumers	Rs. 1.133/kWh
For other Category Consumers	Rs. Zero /kWh


3. For all eligible categories of consumers to whom the Letter of Approval is issued OR who submits their one time option for the change over to the Solar Metering arrangements as per Sub Regulation (2) of Regulation 4 of HPERC(Rooftop Solar PV Grid Interactive System) (Second Amendment) Regulation 2022 on or after **01 Sept 2022**:

Subsidy and/or grant and/or incentive etc. as a percentage of the normative capital cost/benchmark capital cost considered by MNRE or any other Government Agency which provides subsidy	Percentage of weighted average rate to be considered for settlement	Rate for settlement calculated on the weighted average rate per kWh works out to be Rs. 3.777 per kWh
Less than 50%	40%	1.511
50% or more but less than 70%	30%	1.133
70% or more but less than 90%	25%	0.944
90% or more	15%	0.567
