OFFICE ORDER

The Himachal Pradesh State Electricity Board Limited is pleased to adopt the HPERC (Compensation to Victims of Electrical Accidents) Regulations, 2023 as notified by the HPERC vide notification dated 22-07-2023, in toto.

The Himachal Pradesh State Electricity Board Limited is further pleased to repeal all the Policies/Schemes providing for payment of compensation to the victims of electrical accidents issued from time to time, except the Policy decision dated 20-05-2017 relating to providing compassionate assistance to the dependents of deceased HPSEB Ltd. Technical/Engineering Employees who meet with Fatal/Non-Fatal Accidents during their duty hours and the amendments issued thereto from time to time.

The HPSEB Ltd. is further pleased to decide that, notwithstanding anything contained in the aforesaid Policy decision dated 20-05-2017 and the amendments issued thereto, the amount of compensation (in case of death) payable there under shall stand revised to Rs. 5,00,000/- (Rupees Five Lakh only). The aforesaid amount of compensation shall be in addition to the compensation payable under the HPERC (Compensation to Victims of Electrical Accidents) Regulations, 2023.

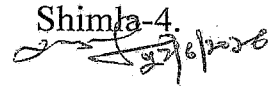
The HPSEB Ltd. is further pleased to nominate and appoint the following officers as the Designated Officers of the Obligated Entity under the HPERC (Compensation to Victims of Electrical Accidents) Regulations, 2023: -

1. The Chief Engineer (P&M) at the Board Level;
2. All the Superintending Engineers within the jurisdiction of their respective Circles; and

3. All the Senior Executive Engineers /Resident Engineers within the jurisdiction of their respective Divisions.

The aforesaid Designated Officers are hereby authorised to consider, decide and disburse the amount of immediate relief in cases of electrical accidents falling within their respective jurisdictions, in accordance with the provisions contained in Chapters III and IV of the HPERC (Compensation to Victims of Electrical Accidents) Regulations, 2023.

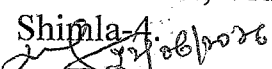
