APPOINTMENT MEMORANDUM

In pursuance to the Executive Director (Pers.) Vidyut Bhawan, Shimla-4 office order No 53/HPSEBL(SECTT)/2021 dated 9-11-2021 endorsement No. HPSEBL (SECTT)/HRD/2-12/2021-50468-85 dated 9-11-2021 and further Sh. Suresh (D.O.B 20-8-93) S/o Sh. Karam Singh (Ref.No. SP-29) is hereby offered appointment as **Junior T/Mate (class-IV)** post in the share of Gen (Sports) purely on contract basis in HPSEBL in the Pay Band – A1 CPB – 4900-10680+1300 Grade Pay + an amount equal to 150 % of Grade Pay with fixed Contractual Emoluments of Rs. 8150/- per month strictly as per R&P Rules and in accordance with modal Roster Notified by the H.P. Govt. and adopted by HPSEBL on the following terms & Conditions.

1. He / She will be paid consolidated monthly emoluments @ Rs, 8150/-(indicate basic pay of initial, pay scale of the post)i.e. **Rs.4900+1300/-Grade Pay+ an amount equal to 150% of Grade Pay.** He / She shall not be entitled for any other allowance whatsoever to the employee of the State Govt./Board from time to time.
2. The appointment shall be purely on contractual basis for a period of one year from the date of joining the post.
3. His / Her age should be between 18 to 30 years as on 1-1-2016. Upper age limit is relaxable by five years for candidates belonging to Schedule Cast, Scheduled Tribe and Other Backward Classes and Children/Grand Children of Freedom Fighters of Himachal Pradesh. The upper age relaxation is also available to Ex-serviceman candidates of H.P. as per provision of relevant rules/instructions of H.P. Govt.
4. His / Her appointment will be subject to the production of medical certificate of fitness from the Chief Medical Officer of the Govt. Hospital.
5. The appointment shall further be subject to terms & conditions of attached from the Contract /Agreement Bond (Annexure-"B") which are to be executed between the candidate and HPSEBL (Appointing Authority) on stamp paper valuing Rs.5/- only duly attested.
6. He / She should give a declaration that he got one living wife or is bachelor.
