


**TERMS AND CONDITIONS:-**

1. He/ She required to produced his/her original Matric qualification/10+2 certificate to the concerned officer before joining the post in proof of his/her qualification and age.
2. He/She is required to produced original certificate from the competent authority to the effect that he/she belongs to the Scheduled caste/Scheduled Tribe/Backward Class community to the officer concerned before joining the post, if he/she belongs to such category.

3. He/She required to produced the latest Non-Employment Certificate, Character Certificate and Himachali Bonafide duly issued by competent authority.
4. He/She will be liable to be transferred/posted anywhere in the exigencies of the Board work wherever there services are required.
5. He/She will furnish declaration in writing that he/she has not been dismissed from any institution/organization under the State Govt./ Govt. of India.
6. He/She will have to take an oath and furnish undertaking in writing that he/She will not leak out official information and shall be liable to punished under the relevant rule.
7. He/She will have to produced a Medical Certificate of fitness duly signed by authorized dignitaries i.e Chief Medical Officer/Medical Officer of the Government indicating he/she is not suffering from any communicable disease.
8. He/She will have to produce a certificate of approval of Character Certificate duly issued by the Competent authority/ Gazetted Officer.
9. His/ Her seniority in the Grade will be assigned later-on in accordance with the relevant rules/instructions.
10. In case he/she is married, he/she shall have to furnish an undertaking in black & white that he and she has only one living spouse writing that he/she has only one living spouse.
11. He/She will be required to take an oath/affirm that he/she have faith and bear true allegiance to the Constitution of India as per law that he/she shall carry out their office duties with loyalty honesty and with impartiality.
