Note:- The matriculation certificate of Sh. Raj Kapoor Singh appearing at Sr. No.46 be verified from the H.P. Board of School education Dharamshala whether the Gurukul Vishwa Vidyala Brindawan (UP) is recognized in H.P. or otherwise.


The regularization of above workmen will be from prospective effect i.e. from the date of issue of appointment order/joining. However, the upper age limit and educational qualification for Class-IV Tech./Non-Tech. is relaxed as per the instruction issued vide letter No.HPSEB (Sectt)/ R&E/ 106/ 11/ 2010-30948-31148 dated 5.6.10. In case of daily waged workers whose cases are pending in different adjudicatories, their services shall be brought on regular basis subject to the final outcome of the Court decision.

You are therefore, directed to issue necessary regularization orders after completion of all codal formalities in respect of above mentioned daily waged workers. There pay will be regulated as per the instructions/notifications issued by HPSEBL from time to time.
