2. While forwarding applications in respect of officers who are about to complete their "cooling-off" period shortly the instructions of DOP&T as contained in O.M. No. 2/1/2012-Estt.(Pay.II) dated 04.01.2013 may be strictly adhered to.
3. A copy of the Application format may be provided by the Borrowing Department in their website in a downloadable form along with the advertisement.
4.
