

OFFICE ORDER

Subject:- Grant of Dearness Allowance to the employees of the Himachal Pradesh State Electricity Board Limited w.e.f. 01.07.2015.

In continuation to this office order endorsement No.HPSEB (SECTT) R&E/ 14-71/2015-49166-386 dated 15.9.2015, the Himachal Pradesh State Electricity Board Ltd. is pleased to order that Dearness Allowance payable to the employees of the HPSEB Ltd. shall be enhanced from the existing rate of 113% to 119% w.e.f 01.07.2015 on the following terms and conditions:-

1. The Additional instalment of Dearness Allowance of 6% (Six percent) shall be paid in cash with the salary of April, 2016 payable in 01st May, 2016 along with arrear accrued w.e.f. 1.3.2016 to 31.3.2016. The arrear accrued w.e.f. 01.07.2015 to 29.2.2016 shall be credited in the General Provident Fund account of the employees with the salary of April, 2016. The interest on this account shall accrue w.e.f. 1st April, 2016. In the case of HPSEB Ltd. employees who have retired or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional instalment of DA w.e.f. 01.07.2015 will be paid in cash with the salary of April, 2016 payable in May, 2016.
2. These orders will be applicable to employees covered by H.P State Electricity Board Ltd. (Revised Pay) Regulations, 2009 and work charged employees working in HPSEB Ltd.
3. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored
