Subject: - Grant of Dearness Allowance to the employees of the Himachal Pradesh State Electricity Board Limited w.e.f. 01.07.2019.


In continuation to this office order endorsement No. HPSEBL (SECTT)R&E/14-71/2019-38111-38310 dated 6.9.2019, the Himachal Pradesh State Electricity Board Ltd. is pleased to enhance Dearness Allowance @ 5% from the existing rate of 148% to 153% with effect from 01.07.2019 in respect of employees of the HPSEB Ltd., and @ 5% from existing rate of 12% to 17% in respect of the officers of All India Services who are drawing pay in the revised pay scales.

1. This additional rate of Dearness Allowance of 5% (Five percent) shall be paid in cash with the salary of March, 2020, payable in April, 2020, and the arrears accrued from 01.07.2019 to 29.02.2020, shall be credited in the GPF Accounts of the employees with the salary of March, 2020. The interest on this account shall accrue w.e.f. 1st April, 2020.
2. In the case of HPSEB Ltd., employees who have retired in between or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f. 01.07.2019 will be paid in cash in the month of March, 2020.
3. These orders will be applicable to regular employees covered by HP State Electricity Board Ltd. (Revised Pay) Regulation, 2009, and work charged employees working in HPSEB Ltd.


