Subject:- Grant of Dearness Allowance to the employees of the Himachal Pradesh State Electricity Board Limited w.e.f.01.07.2021.

In continuation to this office order endorsement No. HPSEBL (SECTT) R&E/14-71/2019-87534-784 dated 21.03.2020, the Himachal Pradesh State Electricity Board Ltd. is pleased to enhance Dearness Allowance @6% from the existing rate of 153% to 159% with effect from 01.07.2021 in respect of the employees of the HPSEBL.

1. This additional rate of Dearness Allowance shall be paid in cash with the salary of September 2021 payable in October 2021, and the arrears accrued from 01.07.2021 to 31.08.2021, shall be credited in the GPF Accounts of the employees with the salary of September, 2021. The interest on this account shall accrue w.e.f.1st October, 2021.
2. In the case of HPSEB Ltd., employees who have retired in between or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f.01.07.2021 will be paid in cash with salary of September, 2021 payable in October, 2021.
3. These orders will be applicable to regular employees covered by HP State Electricity Board Ltd.(Revised Pay) Regulation,2009,and work charged employees working in HPSEBL Ltd.
4. The payment on account of Dearness Allowance involving of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
