OFFICE ORDER

Subject: - Grant of Dearness Allowance to the employees of the Himachal Pradesh State Electricity Board Limited w.e.f. 01.01.2016.

In continuation to this office order endorsement No.HPSEB (SECTT) R&E/ 14-71/2016-7604-7854 dated 22.4.2016, the Himachal Pradesh State Electricity Board Ltd. is pleased to order that Dearness Allowance payable to the employees of the HPSEBL shall be enhanced from the existing rate of 119% to 125% w.e.f 01.01.2016 on the following terms and conditions:-

- j) The Additional instalment of Dearness Allowance of 6% (Six Percent) shall be paid in cash with the salary of October, 2016 payable in 1st November, 2016 and the arrear accrued w.e.f. 01.01.2016 to 30.9.2016 shall be credited in the General Provident Fund account of the employees in the month of October, 2016. The interest on this account shall accrue from 01.11.2016. In the case of HPSEB Ltd. employees who have retired or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional instalment of DA w.e.f. 01.01. 2016 will be paid in cash with the salary of October, 2016 payable in November,2016
- ii) These orders will be applicable to regular employees covered by H.P State Electricity Board Ltd. (Revised Pay) Regulations, 2009 and work charged employees working in HPSEB Ltd.
- iii) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
