Grant of Dearness Allowance to the employees of the Himachal Pradesh State Electricity Board Limited w.e.f. 01.07.2016.

In continuation to this office order endorsement No.HPSEB (SECTT) R&E/ 14-71/2016-56154-374 dated 19.10.2016, the Himachal Pradesh State Electricity Board Ltd. is pleased to order that Dearness Allowance payable to the employees of the HPSEBL shall be enhanced from the existing rate of 125% to 127% w.e.f 01.07.2016 on the following terms and conditions:-

- 1. The Additional instalment of Dearness Allowance of 2% (Two Percent) shall be paid in cash with the salary of February, 2017 payable in I<sup>st</sup> March, 2017 and the arrear accrued w.e.f. 01.01.2017 to 31.01.2017 shall also be paid in cash in the month February, 2017. The arrear accrued w.e.f. 1.7.2016 to 31.12.2016 shall be credited in the General Provident Fund account of the employees in the month of February, 2017. The interest on this account shall accrue w.e.f. I<sup>st</sup> February, 2017. In the case of HPSEB Ltd. employees who have retired or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional instalment of DA w.e.f. 01.07. 2016 will be paid in cash with the salary of February, 2017 payable in March, 2017.
- 2. Other terms and conditions as contained in office order endst. No.HPSEB(SECTT)/R&E/14-17/2010-102161-381 dated 16.1.2010 shall continue to be applicable. However, in the event of revision of pay scales the dearness allowance @ 2% will be admissible on revised basic pay and the difference will be paid in the shape of arrears to the employees.
- 3. These orders will be applicable to regular employees covered by H.P. State Electricity Board Ltd. (Revised Pay) Regulations, 2009 and work charged employees working in HPSEB Ltd.
- 4. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
