Himachal Pradesh State Electricity Board Ltd. is pleased to grant Interim Relief @ 8% of the basic pay (Pay in the Pay Band+ Grade Pay) w.e.f. 1st January, 2016 to be paid, in cash, with the salary of the month of February, 2018, on 1st March, 2018, to its regular employees (Excluding Officers of All India Services) on the following terms and conditions:-

1. No Dearness Relief would be payable on this Interim Relief.
2. These orders shall apply to HPSEB Ltd. regular employees (excluding Officers of All India Services).
3. The arrear accrued on account of grant of this 8% interim relief from 1-1-2016 to 31-1-2018 will be credited to the General Provident Fund Accounts of the concerned employees having GPF Accounts with the salary of February, 2018. The interest on this account shall accrue w.e.f. 1st March, 2018.
4. In case of those HPSEB Ltd. employees who have retired between 1-1-2016 to 31-1-2018 OR who have closed their GPF Accounts and regular HPSEB Ltd. employees who are governed under Contributory Pension Scheme, the arrear on account of release of this 8% additional interim relief w.e.f. 1-1-2016 will be paid in cash with the salary of the month of February, 2018 during March, 2018.
5. This interim relief will be absorbed in future revision of pay scales to be allowed by the HPSEB Ltd.
