Himachal Pradesh State Electricity Board Ltd. is pleased to grant of Interim Relief @ 4% of the basic pay (Pay in the Pay Band+ Grade Pay) w.e.f. 1st July, 2018 to be paid, in cash, with the salary of the month of August, 2018, on 1st September, 2018, to its regular employees (Excluding Officers of All India Services). The total 21% interim relief (5%, 4%, 8% interim reliefs granted earlier and this 4% additional interim relief) shall not be treated as pay for the purposes of calculation and payment of any other kind of allowances including Dearness Allowances. The total amount of 21% interim relief will be absorbed in the future revision of pay scale to be allowed by the HPSEB Ltd. on the following terms and conditions:-

1. No Dearness Allowance would be payable on this Interim Relief.
2. These orders shall apply to HPSEB Ltd. regular employees (excluding Officers of All India Services).
3. The arrears accrued on account of grant of this 4% interim relief from 01-07-2018 to 31-07-2018 in respect of all regular employees will be paid in cash with the salary of the month of August, 2018, during September, 2018.
