You are, therefore, requested to assess all these items well in advance and remove all hording, banners, wall painting writing, photographs and advertisements that depicts the achievements of the various political parties in view of enforcement of provisions of MCC immediately after announcement of General Lok Sabha Election-2024, from your offices as well as from field units functioning under your control and send written compliance report duly authenticated on the prescribed format attached on the same day i.e. day of announcement of election, so that consolidated report could be furnished to the Returning Officer (DC) Shimla.
