Subject: - Regarding withdrawal of additional subsidy by the Govt. of Himachal Pradesh and implementation thereof.

Sir,

This is with reference to the Commission's letter of even file No. 1859-62 dated 20.09.2024 vide which the decision of the GoHP that it shall not neutralize the impact of increase in tariff through additional subsidy in respect of the Domestic category of Consumers with consumption above 300 units/month (falling under 3rd Slab) and Large Industrial Power Supply (LIPS) category of Consumers with effect from 01.10.2024 was conveyed to the HPSEBL and the HPSEBL was directed to take necessary action in the matter and issue bills to the consumers with effect from 01.10.2024 in line with the Tariff Order and as per the GoHP letters dated 18.09.2024.

In this regard, the Commission is in receipt of a letter No. BBNIA/Representation/2024 dated 11.10.2024 from the B.B.N. Industries Association, Baddi (copy enclosed) vide which it has been brought to the notice of the Commission that the HPSEBL has raised bills which pertain to the consumption of Sept, 2024 to the consumers at the tariff arrived at after the withdrawal of additional subsidy provided by the GoHP.

In view of above, I have been directed to convey that the GoHP in the above letters dated 18.09.2024 has clearly spelled out that the GoHP has decided to withdraw the additional subsidy with effect from 01.10.2024 which implies that the subsidy shall be applicable for the energy consumption till 30.09.2024 for the above category of the Consumers. Further, I have also been directed to request you to submit the detailed report to the Commission in this matter within 15 days as to why the energy bills were issued without subsidy for the energy consumption for the months up till September, 2024.

Kindly treat it most urgent.
