OFFICE ORDER

The Himachal Pradesh State Electricity Board Limited is pleased to approve the amendments in the **HPSEBL's Delegation of (Financial, Administration AND HR) Powers, 2022.**

- I. These amendments may be called as **HPSEBL's Fourth Amendments in Delegation of (Financial, Administration AND HR) Powers, 2022.**
- II. These amendments shall come into force from the date of issuance of this office order.
- III. These amendments shall be applicable for the restoration works of Larji HEP (126 MW) only.
- IV. In HPSEBL's Delegation of (Financial, Administrative and HR) Power, 2022 following shall be amended:-

1. In Section I, Delegation of Financial Power 3(ii) shall be substituted as under:-

Note:- The power should be utilized sparingly and in emergency only and the emergent circumstances have to be recorded. These powers are to be used under intimation to the next higher officer.

2. In Section I, Clause 3(iii)(a) shall be substituted as follow:-

<p>Subject to the conditions that:-</p> <p>i) In case of specific works the overall cost is within 5% of the sanctioned estimate.</p> <p>ii) These powers shall not be applicable for the purchase of materials.</p> <p>iii) Rates offered are reasonable and any attempt to over profiling by the contractor is guarded against.</p> <p>iv) The total quantity of works is not split to bring it within the powers of work order.</p> <p>The essence is that this power shall be used for the execution of works which are predominately labour intensive. Any attempt to purchase the material through this route is strictly banned.</p> <p>The prior permission of SE concerned shall have to be obtained if the annual limit as vested to Sr. EEs/REs is exhausted by the Sr. EE. The power vested with XEN (IT) only for revenue works and shall be exercised after approval of SE concerned.</p>
