## **ORDER**

The complaint was listed for filing Rejoinder by the Complainant. None appeared for the complainant despite having knowledge, as evident from the last hearing dated 17.10.2022. The Complainant was provided ample opportunities to file Rejoinder, since Reply filed by the Respondent Board on 15.09.2022 as is evident from the order sheets. The Complainant failed to appear on 15.09.2022, 30.09.2022 and was represented by Miss Anchal Thakur on 17.10.2022. This Forum on 17.10.2022 allowed two weeks' time to file Rejoinder with advance copy to the Respondent Board and categorically directed that this may be treated as last opportunity. Today neither complainant nor any Authorized Representative/Advocate present despite knowledge. The Respondent Board pressed for dismissal of the complaint for non-prosecution in view of the intentional delay to dispose of the matter and failure to appear and file the Rejoinder by the Complainant despite knowledge. The Respondent Board also prayed for vacation of interim order passed in complaint.

The Complainant failed to appear and file the Rejoinder before this Forum despite affording sufficient time and opportunity to do so as observed here-in-above. The conduct of the complainant clearly demonstrate that the complainant is not interested to pursue the present complaint to its logical end delaying its disposal on one pretext or another, as is evident from record. The matter has been delayed for none appearance/non prosecution by the Complainant, as is evident from the record and conduct of Complainant. This Forum is of the opinion that the complainant is not interested to pursue the Complaint and delaying its disposal for reasons best known to it.

In view of the observations made above, the present complaint is dismissed in default for non-appearance and non-prosecution by the Complainant. Parties are left to bear their own costs. The Interim Order if any, shall also stand vacated. The Complainant be intimated separately through post.

Order is announced before the parties present today on 14.11.2022 at Shimla in open Forum.
