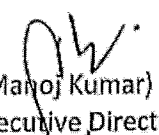

The examination will take place at H.P. Public Services Commission, Nigam Vihar, Shimla-2./Govt. Degree College (Center of excellence) Sanjauli at Shimla. For details of the said Examination, candidates are requested to refer to the regulations for the Departmental Examination for the Engineering Officers of the H.P. State Electricity Board circulated vide notification No. HPSEB (SECTT) / 105-14/R&E/ 87-16622-802 dated 25.2.88 and further amended vide notification No. HPSEBL (SECTT) / R&E / 105-14 / 2020-85419-619 dated 17.03.2020.

According to these regulations, Assistant Engineers have to pass the examination within three years (viz. six chances for appearing in the examination) from the joining of their service or the date of notification of these regulations, (whichever is later). It has also been specified in these regulations that if an officer fails to pass the departmental examination, he will neither be considered for promotion to the next higher grade nor will be considered for confirmation in the existing rank and grade.

It is, therefore, requested to please bring to the notice of all concerned officers working under your respective control that they should pass the departmental examination within stipulated period/chances failing which, they will not be considered for confirmation and promotion. They are directed to submit their applications on line on Manav Sampada Portal. Candidates desirous of appearing in the examinations will be able to make their applications from 13.07.2022 to 16.08.2022. The application will be considered when the same will be approved / verified by their respective Head of Departments. The window of the HOD's to verify and forward the application on line will remain open till 22.08.2022. Thereafter, window will automatically closed. Applications received in physical forms shall not be entertained / accepted. However complete information about the process of online application for applicant and head of department and time table of examination is available on HIPA website www.hipashimla.nic.in, can be downloaded.

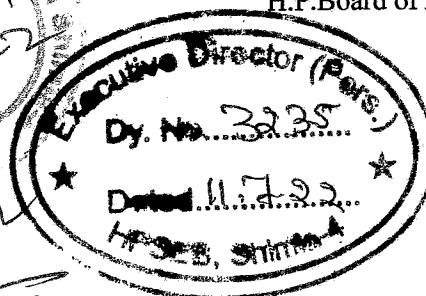
