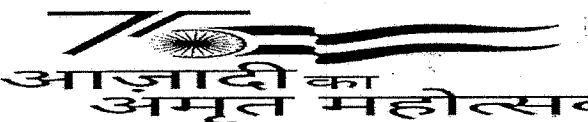


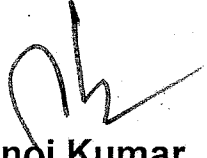

Ban on transfers- Instructions thereof.

Sir/Madam,

I am directed to invite your attention to this Department's letters of even number dated 09.05.2022 and 15.07.2022 on the subject cited above vide which a complete ban has been imposed on general transfers of employees with clear stipulations that no transfers or adjustments will be ordered by any Department/Board/Corporation/Universities etc. during the ban period without the prior approval of the Hon'ble Chief Minister through the concerned Minister - in-charge, that too in the circumstances specifically provided Para 8 of Comprehensive Guiding Principal-2013 circulated vide OM No. Per(AP-E)-E(3)-17/2012 dated 10.07.2013.

2. As per the Para 8 of the policy *ibid*, the transfer orders can be issued with the prior approval of Hon'ble Chief Minister only in the following circumstances:

- i. To fill up vacant posts in tribal/difficult/hard areas;
- ii. To fill up vacancies arising out of retirements, promotions and creation of new posts;
- iii. Transfers necessitated on account of disciplinary matters, vigilance cases, criminal proceeding etc.
- iv. In cases involving administrative grounds and exigencies.

3. As the ban on general transfers continues to be in force, therefore, no transfer order is to be issued without prior approval of the Hon'ble Chief Minister, that too in the circumstances mentioned above.

4. These instructions may be brought to the notice of all concerned for strict compliance.
