WHEREAS, Sh. Naresh Kumar, Superintendent Grade-II, presently working in the Office of the Sr. XEN (ES) Division, HPSEBL, Una, was charge-sheeted under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, vide Office Order No. 1084 dated 18.11.2022 issued by the Vigilance & Investigation Department, HPSEB Ltd.;

AND WHEREAS, the disciplinary proceedings so initiated against Sh. Naresh Kumar, under Rule 14 of the CCS (CCA) Rules, 1965 have since culminated in his exoneration by the competent Disciplinary Authority, vide Office Order No. HPSEBL (SECTT)V&I/SZ/8-2760/2026-556-67 dated 07.07.2026;

AND WHEREAS, upon his exoneration from the disciplinary proceedings, the case of Sh. Naresh Kumar for promotion to the post of Section Officer was considered by the competent Departmental Promotion Committee, and the Committee has recommended his promotion to the said post on regular basis;

NOW, THEREFORE, the Himachal Pradesh State Electricity Board Ltd., in pursuance of the recommendations of the Class-I Departmental Promotion Committee and with the approval of the competent authority, is pleased to promote Sh. Naresh Kumar, Superintendent Grade-II (DOB: 08.10.1973), to the post of Section Officer on regular basis in Level-17 of the Pay Matrix of Rs. 52,600-1,66,600/-, as prescribed under the HPSEB Ltd. (Revised Pay) Regulations, 2022, with effect from 02.07.2026 (on notional basis,) i.e. from the date on which his immediate junior, Smt. Anju Bala (DOB: 15.09.1973), was promoted to the post of Section Officer vide Office Order No. 76 dated 02.07.2026, endorsed vide even file No. 19541-595 dated 21.07.2026.

The aforesaid notional promotion shall, however, not entitle the officer to any arrears of pay or other consequential monetary benefits for the period prior to his actual assumption of charge as Section Officer. The actual financial benefits arising out of the promotion shall accrue to him only from the date he assumes charge of the post of Section Officer, subject to fixation of his pay under the applicable provisions of the HPSEB Ltd. (Revised Pay) Regulations, 2022.

On promotion, Sh. Naresh Kumar shall be assigned seniority in the cadre of Section Officers below Smt. Sita Devi (DOB: 15.04.1972), appearing at Sr. No. 9 (Seniority No. 23), and above Smt. Anju Bala (DOB: 15.09.1973), appearing at Sr. No. 11 (Seniority No. 25), in accordance with the inter-se seniority position determined on the basis of the final Seniority List of Superintendent Grade-II as it stood on 31.03.2025, circulated vide letter dated 05.03.2026.

The official on his promotion as Section Officer on regular basis should exercise his option with regard to date of increment / pay fixation under the provision of Pay Regulation 8 (iv) within a period of one month after assuming the charge of the post.

Consequent upon above promotion of Sh. Naresh Kumar Supdt. Gr-II, presently working in the O/O Sr. XEN. (ES) Division HPSEBL Una, is hereby posted in the O/o CE (ES) HPSEBL, Hamirpur against vacancy, with TTA/J/T as admissible under the rules.

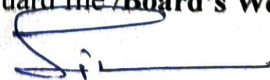
