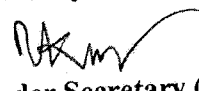

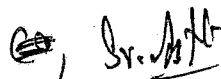

This bears the approval of the competent authority.

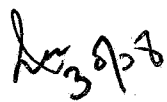

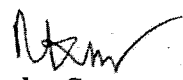
