Personnel (Reservation of Vacancies in H.P. Non Tech. Services Rules) 1972
on their re-employment.

Sir,

I am directed to refer to your department's letter No. HPSEBL/F&A/Pay Fix-
Ex.men/2019-20-5228 dated 13.02.2020 on the subject cited above and to say that the matter
has been examined in consultation with the Personnel Department who has advised as under:-

Examined. As per amended Rule 5(1) of the Demobilized Armed Forces
Personnel (Reservation) of Vacancies in Himachal State Non-Technical
Services Rules, 1972, the period of approved military service rendered
after attaining the minimum age and qualification prescribed for
appointment to the service concerned, by the candidate(s) appointed
against reserved vacancy under the relevant rules, shall count towards
fixation of pay in that service at the time of first civil appointment against
reserved vacancy. Therefore, the benefit of such military service towards
pay fixation cannot be allowed when the Ex-servicemen had not attained
the minimum age and qualification prescribed for appointment to that
civil post.

You are, therefore, requested to take necessary action in the matter in accordance
with the advice of the Personnel Department.
