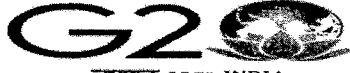

NOTIFICATION

In exercise of powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following rules further to amend the Central Civil Services (Joining Time) Rules, 1979, in their application to the State of Himachal Pradesh, namely :-

- Short title and commencement: 1. (1) These rules may be called the Central Civil Services (Joining Time) Himachal Pradesh Amendment, Rules, 2023.
- (2) They shall come into force from the date of their publication in Rajpatra (e-Gazette), Himachal Pradesh.

- Amendment of rule Rule-5 2. In the Central Civil Services (Joining Time) Rules, 1979, for sub-rule (4), the following shall be substituted, namely:-

"In cases involving transfer from one station to another and also change of residence, the Government servant shall be allowed joining time with reference to the distance between the old and the new headquarters by direct route and ordinary mode (s) of travel as indicated in the following schedule. When holiday (s) follow(s) joining time, the normal time may be deemed to have been extended to cover such holiday (s).

हिमाचल प्रदेश के राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, सेंट्रल सिविल सर्विसिज (ज्वाइनिंग टाइम) रूलज, 1979 का हिमाचल प्रदेश में इनके लागू होने पर और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

- संक्षिप्त नाम और प्रारंभ । 1. (1) इन नियमों का संक्षिप्त नाम सेंट्रल सिविल सर्विसिज (ज्वाइनिंग टाइम) हिमाचल प्रदेश अमेंडमेंट रूलज, 2023 है ।
(2) ये राजपत्र (ई-गजट), हिमाचल प्रदेश में इनके प्रकाशन की तारीख से प्रवृत्त होंगे ।
- नियम 5 का संशोधन । 2. सेंट्रल सिविल सर्विसिज (ज्वाइनिंग टाइम) रूलज, 1979 में उप-नियम (4) के स्थान पर निम्नलिखित रखा जाएगा, अर्थात् :-

"In cases involving transfer from one station to another and also change of residence, the Government servant shall be allowed joining time with reference to the distance between the old and the new headquarters by direct route and ordinary mode (s) of travel as indicated in the following schedule. When holiday (s) follow(s) joining time, the normal time may be deemed to have been extended to cover such holiday (s).
