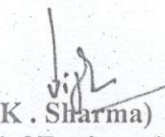

All the above named officials in whose cases change of station is involved shall be entitled to usual joining time and TTA as admissible under the Rules.

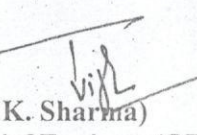
