It is in continuation to this office employment notice against advertisement No.2 dated 08/11/2021 vide which the HPSEBL has notified the mode of selection w.r.t. filling up 100 posts of Driver on daily wages basis. Out of 100 posts of Driver, 82 posts of Driver as per model roster will be filled up through departmental selection procedure, remaining 15 posts of Driver in the share of ESM quota and 03 posts of Driver in the share of Sports quota will be filled up through recruitment agency whereas written test w.r.t. 82 posts of Driver on daily wages basis are yet to be conducted.

In this regard, it is informed to all concerned that the Government of Himachal Pradesh vide Notification No. Per(AP-B)B(15)11/2018 dated 4th May, 2022 has now decided to discontinue /dispense with the process of evaluation of 15 Marks and to enhance the weightage of written test from 85 to 100 for Class-III posts/services under the State Government with immediate effect. The Selection to all class-III posts/Services under State Government shall be made on the basis of merit of written examination/screening test/skill test.

Therefore, Mode of Selection in r/o the above mentioned post advertised vide advertisement No.2 dated 08/11/2021 will be processed further as under:-

5. Mode of Selection:

The total selection process is of 100 Marks with following distribution:-

8.	Waiting list will also be prepared for each category and will remain valid for one year from the date of declaration of result subject to further extension by competent authority.	

7. Driving Test

On the basis of score obtained in written test the shortlisted candidates (categories wise) will appear for driving test to be conducted at designated place, date and time . This test will be conducted by a committee notified by the HPSEBL. Schedule of Driving Test will be notified through website of HPSEBL.

This committee will conduct the Driving Test on the following parameters:-

1. **Precaution before starting vehicle.**

- (i) Air Pressure.
- (ii) Starting of vehicle in neutral position i.e. his way of opening of window, sitting posture.
- (iii) Adjustment rear view mirror.

2. **Important checklist by a driver before moving the vehicle or sitting on driving seat.**

- (i) Instrument cluster, gauges indicated etc.

3. **General control of the vehicle by confident steering and smooth gear changing & breaking.**

- (i) Which gear he choose for moving first.
- (ii) Steering judgment on forward drive.
- (iii) Changing gear smoothly according to road & load.
- (iv) Use of brake.
- (v) Judgment of steering on reversing the vehicle.
- (vi) Accelerator control.

4. **Driving skill test :-**

Candidate has to pass the " **Track Driving Test**" including Parking on service dug (parking facing uphill, downhill), forward & reverse successfully, if candidates fails to do so, he will be disqualified. Such candidates will not be considered for further selection process irrespective of marks scored by him/her in written examination.
