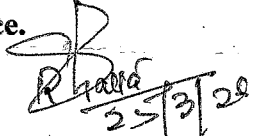

The above named official will be entitled to TTA and joining time as admissible under rules.

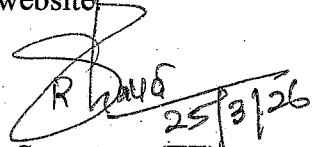
