forces Personnel (Reservation of Vacancies in H.P. Non
The. Services rules) 1972 on their re-employment.

Sir,

I am directed to refer to your letter No.HPSEBL/F&A/Pay
Fix-Ex.men/2021-1387 dated 10.08.2021 on the subject cited above and to
say that the matter was taken up with the Personnel Department who has
advised as under:-

*"The State Government in the department of Personnel vide
letter No. PER(AP)-C-B(12)-1/2013 dated 01.04.2021 has issued
instructions, clarifying that the matter of pay fixation of Ex-Servicemen
pending for decision only upto 29.01.2018, be disposed of in accordance
with para-5(ii) of instructions dated 25.09.2019, allowing benefit of
counting past service rendered in the armed forces towards pay fixation
without imposing the condition of minimum age and qualification and the
settled position may not be unsettled. Therefore, the department is advised
to examine & decide the matter of pay fixation of ex-servicemen who have
joined the civil services on regular basis prior to issuance of notification
dated 29.01.2018, without imposing the condition of minimum age and
qualification."*

You are, therefore, requested to take necessary action in the
matter accordingly.
