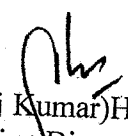

OFFICE MEMORANDUM

Subject:- Payment of arrears to pre-2016 pensioners/family pensioners on account of revision of pension/family pension w.e.f. 01-01-2016.

The undersigned is directed to refer to the para-10 of this Department Office Memorandum No. Fin(Pen)A(3)-1/2021-Part-II dated 25.02.2022 and to say that the Governor, Himachal Pradesh is pleased to order that 20% of the pension/family pension arrears, w.e.f. 01.01.2016 to 31.01.2022 accrued to pre-2016 pensioners/ family pensioners on account of revision of pension/ family pension w.e.f. 01.01.2016, may be paid, subject to ceiling of Rs 50 000/-, in the month of September, 2022, after making necessary adjustments, as stated in para 2 below.

1st, 2nd, 3rd, 4th, instalment of Interim Relief already paid vide this Department Office Memoranda No. Fin. (Pen) B (10)-6/98-III dated 02.03.2016, 04.08.2017, 09.02.2018, 20.08.2018 and twelve instalments of Dearness Relief sanctioned earlier vide Office Memoranda No. Fin (Pen) B (10)-6/98-III dated 03.10.2016, 07.04.2017, 11.09.2017, 08.01.2018, 30.10.2018, O.M. No. Fin (Pen) B (10)-6/98-IV dated 18.02.2019, 21.08.2019, 07.03.2020, 15.09.2021 respectively, may be adjusted against the gross pension/family pension arrears and only net amount may be paid. In case the amount of pension/family pension arrears as stated in para 1 above is not sufficient to adjust the amount of Interim Relief and Dearness Relief already paid and any amount still remains to be adjusted, the same shall be adjusted against the future release of pension arrears/family pension arrears and Dearness Relief.

It shall be the responsibility of Pension Disbursing Authorities including Public Sector Banks to ensure adjustment as stated above at the

earliest and the balance amount only may be paid to the pensioners/family pensioners.
