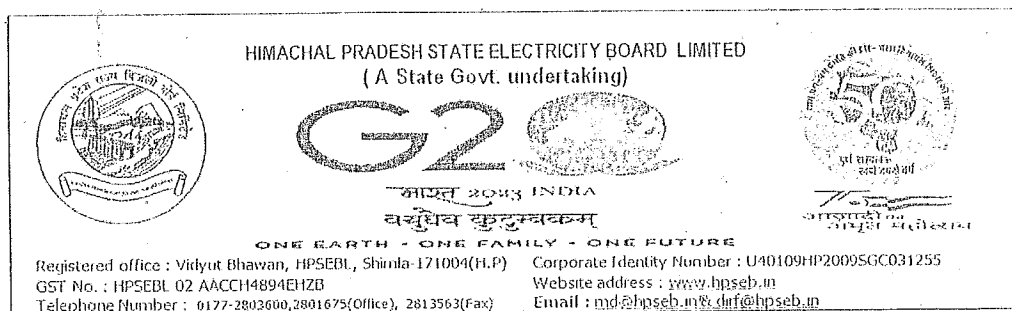




“ OFFICE ORDER ”

In continuation of this office order No.40 HPSEBL (SECTT.) /2022- dated 09-06-2022 and further endorsed vide No. HPSEBL (SECTT.)/HRD/2-12/2022-22199-22207 dated 09/ 06/ 2022 , the Himachal Pradesh State Electricity Board Ltd. is pleased to provide similar treatment to Shri Gurpreet Singh , who was earlier appointed as Junior T/Mate (now T/Mate) on Contract Basis under ED, HPSEBL, Kaza vide above referred order, on the analogy and judgment dated 20-12-2021 passed by the Hon'ble High Court in CWP No.5056 of 2022 titled as Susheel Kumar VS HPSEBL and other which stands already implemented vide this office order No.46 dated 11/07/2022 (**Annexure-“A”**) with regard to Shri Gurpreet Singh is treated to have been appointed in service notionally from the date when his juniors came to be appointed from the same selection process, the monetary benefits will be payable to him only from the date when he has actually joined the department, the period between the notional appointment and the actual appointment shall count towards seniority and also increments and

his pay shall be fixed accordingly, In other words , the petitioner shall be entitled to salary , as he is being drawn by other similar situate persons who have been appointed in the same selection process from the date he joins or has joined service of the HPSEBL.

The further action qua, order by named shall be issued /initiated by the concerned Sr. Executive Engineer, ED, HPSEBL, Kaza being cadre controlling authority immediately at their own level , under intimation to this office.
