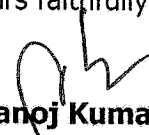

Sir/ Madam,

I am directed to invite your kind attention to the order of Hon'ble High Court dated 10-03-2023 in LPA No. 19 of 2023- titled as State of H.P. & Ors. Vs. Nek Ram, whereby, directions have been given to issue necessary instructions for the implementation of the HP State Litigation Policy, 2011.

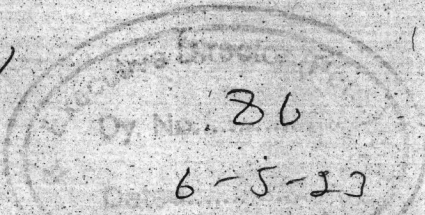
In this regard, the state Government has approved the litigation policy which outlines the broad guidelines with a view to reduce litigation to save avoidable cost on unproductive litigation and thus helping to reduce avoidable load on the Courts with respect to Government induced litigation (policy is available on website www.himachal.nic.in/home). In order to ensure the implementation of the policy, a "Standing Committee" under the Chairmanship of the Chief Secretary to the Govt. of H.P. comprising of the Secretaries Finance, Personnel, Law and Administrative Secretaries of concerned departments as its members is already in place to examine the cases involving huge financial implications or inter-departmental ramifications which can then be adopted by other departments in similarly situated cases. Also every agency of the Government is under obligation to make endeavor not to file/ continue with appeals /revisions etc. unless the State or an agency believes that it has reasonable prospects for success or the appeal is otherwise justified in the public interest or on substantial questions of law, provided that a decision to file/ continue the appeal is made as soon as practicable. As such, the said Litigation Policy came to be introduced.

It, is, therefore, requested to adhere to the instructions issued by this department from, time to time, in this regard, for implementation of State Litigation Policy, 2011 as well as the directions of this Hon'ble High Court and to direct all controlling officers to ensure monitoring of such cases on regular basis and to hold regular meetings of the Departmental Litigation Monitoring Committee to take necessary steps to reduce unnecessary litigation.

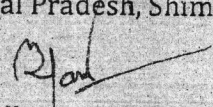
