ORDER

Complainant bearing consumer ID 100010002862, address M/s Param Industries , Village Johron , Kala Amb, Distt Sirmour HP, being aggrieved with Demand Notice dated 07.02.2022 raised by the Respondent HPSEBL for the payment of Rs.2,18,830/- as arrears for the period 01.01.2019 to 30.04.2020, had filed the instant Complaint.

On the last date of hearing matter was argued by both parties and Respondent HPSEBL was directed to supply the breakup of arrears based on Time of Day (TOD) consumption to the Complainant;

Today Assistant Engineer, Electrical Sub-Division, HPSEBL Kala Amb, District Sirmour, HP is also present who has placed on record revised calculation sheet based on MRI data, vide which an amount of only Rs.8,737/- is payable by the Complainant for the ibid period January 2019 to April 2020. Copy of this revised calculation sheet has also been received by the Complainant;

Complainant conveys that he is satisfied with the aforesaid revised calculation sheet / settlement and prays for disposing of the complaint along with prayers that any excess amount deposited by the Complainant be adjusted in future bills;

Prayer granted. Respondent HPSEBL is directed to adjust this settled amount in the next electricity bill of the Complainant;

In view of foregoing, nothing remains in the instant Complaint to be decided by the Forum;

On aforesaid terms, the complaint is disposed of as settled.

Parties are left to bear their own costs.
